WHEREAS, the current contract with Alliance Rehab allows for the extension of said contract for two one (1) year renewal options, if the County so chooses, and

WHEREAS, the Purchasing Director and Sunny Hill Administration have recommended, and the Executive Committee has concurred, that the contract for therapy services at Sunny Hill Nursing Home with Alliance Rehab be renewed for an additional year, and

WHEREAS, sufficient appropriations have been budgeted in the Sunny Hill Nursing Home's Budget.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contract with Alliance Rehab for Therapy Services (physical therapy, occupational therapy and speech therapy) at Sunny Hill Nursing Home for an additional year commencing January 2, 2015, through and including January 1, 2016.
