WHEREAS, the Maintenance Director has recommended, and the Executive Committee has concurred, that the contract for elevator maintenance services be renewed with Anderson Elevator Company of Broadview, IL, for a total cost of \$30,168.00, for the period of December 1, 2015 through and including November 30, 2016, and

WHEREAS, sufficient appropriations have been budgeted in the County Executive's Building Maintenance Budget.




