Renewing Contracts for Medical Products at Sunny Hill Nursing Home

WHEREAS, the current contracts for medical products for Sunny Hill Nursing Home will expire on November 30, 2015, and

WHEREAS, the current contracts allow for the extension of said contracts at one year intervals, if the County so chooses, and

WHEREAS, the Purchasing Director and Nursing Home Administrator have recommended, and the Public Health & Safety Committee has concurred, that the contracts for medical products for Sunny Hill Nursing Home be renewed for one year from December 1, 2015, through and including November 30, 2016, with the following vendors: Professional Medical & Surgical Supply, Inc, New Lenox, IL, Medline Industries, Inc, Mundelein, IL, and McKesson Medical-Surgical Minnesota Supply Inc, Golden Valley, MN with a 3% increase for each vendor. The contract amounts will vary depending upon actual amount used and facility census, and

WHEREAS, sufficient appropriations have been budgeted for this purpose.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contracts for medical products for Sunny Hill Nursing Home for one year from December 1, 2015, through and including November 30, 2016, with the following vendors: Professional Medical & Surgical Supply, Inc, New Lenox, IL, Medline Industries, Inc, Mundelein, IL, and McKesson Medical-Surgical Minnesota Supply Inc, Golden Valley, MN with a 3% increase for each vendor. The contract amounts will vary depending upon actual amount used and facility census.


BE IT FURTHER RESOLVED, that such purchases shall be funded through the Sunny Hill Nursing Home Budget.
