WHEREAS, after reviewing such proposals, the recommendation is to award the bid to the lowest responsible bidder of Forum Extended Care, Chicago, IL, pursuant to the terms and specifications of the attached Bid History Sheet, and

WHEREAS, the Executive Committee concurs with this request.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the contract for pharmaceutical services for Sunny Hill Nursing Home to the lowest responsible bidder of Forum Extended Care, Chicago, IL, pursuant to the terms and specifications of the attached Bid History Sheet, for one year, commencing March 1, 2015 through February 29, 2016, with two (2) one (1)-year renewals, if the County so chooses.
