**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

**VOIDING BID FOR PERMIT AND CASE SYSTEM
FOR THE LAND USE DEPARTMENT**

WHEREAS, in order to receive the most competitive price available, the Will County Executive's Office solicited bids for a permit and case system for the Land Use Department, and

WHEREAS, on November 8, 2013, the Will County Executive's Office opened four (4) proposals, and

WHEREAS, two bids were rejected leaving two qualified bids. After review and consideration it was determined to void the bids due to exceeding identified funding. In addition, there were changes in scope and specifications that have come to light upon a review of the bid responses. These changes while not excessive, are significant. Permission is being requested to void the bid, make necessary changes and re-issue the bid as altered, and

WHEREAS, Staff has recommended that the bid for a permit and case system for the Land Use Department be voided and requests permission to reissue the bid, and


WHEREAS, the Executive Committee concurs with their request.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby voids the bid for a permit and case system for the Land Use Department and authorizes Staff to work with the Will County State's Attorney and Will County Purchasing Director to redesign the bid specifications and reissue as altered.


