WHEREAS, on September 16, 2015, the Will County Executive's Office opened eight (8) proposals for exam gloves, and

WHEREAS, after reviewing such proposals, the recommendation is to award the bid to the lowest responsible bidder, Medline Industries, Mundelein, IL, pursuant to the terms and specifications of the attached Bid Tab Sheet, beginning December 1, 2015 through November 30, 2016, with two (2) additional one (1) year renewal options, if the County so chooses, and

WHEREAS, the Public Health & Safety Committee concurs with this request.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby awards the contract for exam gloves for Sunny Hill to the lowest responsible bidder, Medline Industries, Mundelein, IL, pursuant to the terms and specifications of the attached Bid Tab Sheet, beginning December 1, 2015 through November 30, 2016, with two (2) additional one (1) year renewal options, if the County so chooses.


BE IT FURTHER RESOLVED, that such purchases shall be funded through Sunny Hill's Budget.

Adopted by the Will County Board this 15th day of October, 2015.


