

Report of Total Compensation as required by Public Act 097-0609, (5 ILCS 120/7.3)

Annual Salary: The annual salaries provided here are based on the hourly rates and scheduled hours in effect as of October 31, 2016. Payments made for employment longevity have been included. The assumption made for this posting is that Bargaining Unit employees will receive the contractual increase per contract. If a labor contract is or will be under negotiation, then an average step increase was used. The calculation of annual wages for this report uses an average for all step increases, actual step increase percentages may vary slightly. Only filled full time and part time positions have been included; vacancies and temporary workers are not listed. Some departments compensate employees for working additional hours or taking on additional duties by paying overtime or stipends, those payments have not been included.

Health Insurance: Will County is self insured, which means we pay the actual cost of health claims and a fee for administration of our plans, rather than a premium for coverage purchased through a health care provider. The estimated annual cost of health insurance for fiscal year 2017 per full time equivalent (fte) is \$17,100. Employees contribute toward the cost of health coverage based on the insurance options they elect. We will not be providing the actual cost to the county for health claims per employee or the type of plan or coverage selected by employees due to HIPPA laws. In FY15 the total net cost of health insurance was \$34,636,946, or approximately \$15,470 per fte. Final figures for fiscal year 2016 are not yet available.

Housing Allowance: Will County does not provide Housing Allowances.

Vehicle Allowance: Will County does not provide Vehicle Allowances.

Clothing Allowance: Provided per Labor Contracts.

Bonuses: Will County does not provide bonuses.

Loans: Will County does not provide loans.

Vacation Days: Vacation Days are granted based on length of employment with the County. In general, most employees earn 2 weeks of paid vacation after 1 year of service, 3 weeks after 5 years of service, 4 weeks after 10 years of service, and 5 weeks after 15 years of service. Part-time employees that are eligible earn vacation time on a pro-rata basis. Hours earned in the prior 12 month period have been provided for this report. New hires or employees on alternate earnings schedule may show -0-, however it is assumed that they will earn vacation based on the general schedule described here.

Sick Days: Full Time employees earn one sick day per month for a total of 12 days or 96 hours per year. Part-time employees, that are eligible, earn sick time on a pro-rata basis.

Pension: Annual contribution rates are provided by the Illinois Municipal Retirement Fund (IMRF). Rates for both the Employee share and the Employer (County) share for 2017 are below:.
