WHEREAS, the current contract allows for the extension of said contract for a three (3) year renewal option, if the County so chooses, and

WHEREAS, the Purchasing Director and the Telecommunications Manager recommend that the contract for telephone maintenance be renewed with Altura Communication Solutions, LLC, for the period of September 1, 2017 through and including August 31, 2020, and

WHEREAS, sufficient appropriations have been budgeted in the County Executive's Budget, and

WHEREAS, the Executive Committee concurs with the recommendation.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the Will County Executive to renew the contract for telephone system maintenance with Altura Communication Solutions, LLC, for the period September 1, 2017 through and including August 31, 2020.

BE IT FURTHER RESOLVED, that the Preamble of this Resolution is hereby adopted as if fully set forth herein. This Resolution shall be in full force and effect upon its passage and approval as provided by law.
