***Renewing Contract for Telecommunications Time & Material***

WHEREAS, the current contract for telecommunication time and material service will expire on October 31, 2016, and

WHEREAS, the current contract with ConvergeOne, Eagan, MN, allowed for two (2), one (1)-year renewal options, if the County desired to do so, and

WHEREAS, the Purchasing Director has recommended, and the Executive Committee has concurred, that the contract for telecommunications time and material service with ConvergeOne, Eagan, MN, be renewed for an additional year, rates based on original bid documents stating for not more than 4% or CPI on a per hour basis, whichever is greater. The new contract period will commence November 1, 2016, through and including October 31, 2017.



Adopted by the Will County Board this 15th day of September, 2016.



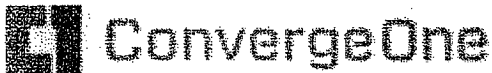
