WHEREAS, the Purchasing Director and Sunny Hill Administration have recommended, and the Public Health & Safety Committee has concurred, that the contract for exam gloves with Medline Industries, Mundelein, IL, be renewed for an additional year, from December 1, 2016 through November 30, 2017. The estimated annual contract amount will remain at \$41,625.00, as stated on the original bid documents.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contract for exam gloves for Sunny Hill Nursing Home with Medline Industries, Mundelein, IL.


BE IT FURTHER RESOLVED, that such purchases shall be funded through the Sunny Hill Nursing Home Budget.


