WHEREAS, the current contract allows for the extension of said contract for two one (1) year renewal options, if the County so chooses, and

WHEREAS, the Purchasing Director and Sunny Hill Administration have recommended, and the Public Health & Safety Committee has concurred, that the contract for therapy services at Sunny Hill Nursing Home with Alliance Rehab, Warrenville, IL, be renewed for an additional year, from February 1, 2017 through January 31, 2018, and

WHEREAS, sufficient appropriations have been budgeted in the Sunny Hill Nursing Home's Budget.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contract for therapy services (physical therapy, occupational therapy and speech therapy) at Sunny Hill Nursing Home with Alliance Rehab, Warrenville, IL, for an additional year, from February 1, 2017 through January 31, 2018.
