***Renewing Contract for Diabetic Supplies for Sunny Hill Nursing Home***

WHEREAS, the current contract for diabetic supplies at Sunny Hill Nursing Home with Medline Industries, Mundeline, IL, expires on August 31, 2018, and

WHEREAS, the current contract allows for the extension of said contract at one year intervals, if the County so chooses, and

WHEREAS, the Purchasing Director and Nursing Home Administrator have recommended, and the Public Health & Safety Committee has concurred, that the contract for diabetic supplies for Sunny Hill Nursing Home with Medline Industries, Mundeline, IL, be renewed for one year from September 1, 2018, through and including August 31, 2019. The contract amount will be approximately \$8,274.24, as stated in the original bid documents, and

WHEREAS, sufficient appropriations have been budgeted for this purpose.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contract for diabetic supplies at Sunny Hill Nursing Home with Medline Industries, Mundeline, IL, for one year, September 1, 2018, through and including August 31, 2019.





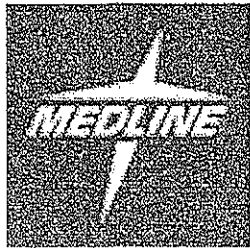
