



**RESOLUTION OF THE COUNTY BOARD
WILL COUNTY, ILLINOIS**

Awarding Bid for Grounds Care/Snow Removal at Public Safety Complex

WHEREAS, in order to obtain the most competitive rates for grounds care and snow removal for the Public Safety Complex, proposals were solicited, and

WHEREAS, on October 25, 2017, the County Executive's Office opened four (4) bids to provide grounds care and snow removal for the Public Safety Complex, and

WHEREAS, the County Executive's Staff has recommended, and the Executive Committee has concurred, that a contract be awarded to the lowest responsible, responsive bidder of Eternally Green, Frankfort, IL, for the first year approximate annual amount of \$6,900.00 for grounds care and D&J Landscape, Plainfield, IL for the first year approximate annual amount of \$32,890.00 for snow removal. These contracts will begin December 1, 2017 and continue through November 30, 2018 with two (2) additional one (1) year optional renewals, if the county so chooses, with no increase in rates for years two and three. The successful bidders will be awarded the contract based on a 90-day trial period. If the successful bidder does not comply with the specifications as written, that bidder will be dismissed from all duties, and the county will select the next lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to execute contracts with Eternally Green, Frankfort, IL, for the first year approximate annual amount of \$6,900.00 for grounds care and D&J Landscape, Plainfield, IL for the first year approximate annual amount of \$32,890.00 for snow removal for the Public Safety Complex. These contracts will begin December 1, 2017 and continue through November 30, 2018 with two (2) additional one (1) year optional renewals, if the county so chooses, with no increase in rates for years two and three. The successful bidders will be awarded the contract based on a 90-day trial period. If the successful bidder does not comply with the specifications as written, that bidder will be dismissed from all duties, and the county will select the next lowest responsible bidder.





On October 25, 2017, contractor bids were open for grounds and snow removal services for the Public Safety Complex, 16911 Laraway Rd, Joilet, Illinois. Three bids were received for grounds and two for snow removal. One bidder's bid was disqualified for grounds and snow removal.

After reviewing deposits, prime certificate, references, forms, and pricing data, my recommendations are as follows:

Award the Grounds Contract to Eternally Green in Frankfort, IL as the low bidder at \$230 cost per week for the first year with two option years starting December 1, 2017.

Award the Snow Removal Contract to D&J Landscape in Plainfield, IL as the low bidder at \$1495 cost per occurrence for the first year with two option years starting December 1, 2017.
